	<p>iii. Japan had modernized itself and had resisted colonization by the west.</p> <p>iv. Vietnamese students established a branch of the Restoration Society in Tokyo but after 1908, the Japanese Ministry stopped them to do so. Many, including Phan Boi Chau, was deported and forced to seek exile in China and Thailand.</p> <p><b>OR</b></p> <p>'The idealistic liberal- democratic sentiment of nationalism became a narrow creed with limited ends.' Support the statement in the context of Balkan nationalism in the early 19<sup>th</sup> century.</p> <p><b>The Balkans</b> comprised modern-day Romania, Bulgaria, Albania, Greece, Macedonia, Croatia, Bosnia-Herzegovina, Slovenia, Serbia and Montenegro.</p> <p>i. The disintegration of the ruling Ottoman Empire and the spread of the ideas of romantic nationalism made this area explosive.</p> <p>ii. The European subject nationalities started breaking from its control to declare independence.</p> <p>iii. The Balkan revolutionaries' acts were directed to gain back the long-lost independence.</p> <p>iv. The Balkan States were fiercely jealous of each other and wanted to gain more territory at the expense of the other.</p> <p>v. There was intense rivalry among the European powers over trade, colonies, naval might and military might. European powers such as Russia, Germany, England and Austro-Hungary were keen on opposing the hold of other powers over the Balkans for extending their own area of control.</p> <p>vi. All these events ultimately triggered the <b>First World War (1914)</b>.</p>

20.	<p>Why do we need to expand formal sources of credit in India? Give three reasons.</p> <p>Ans.</p> <p>i. The cost of informal loans is much higher and often leads to a debt trap. Also, people who might wish to start a new enterprise by borrowing may not do so because of the high cost of borrowing in such a case.</p> <p>ii. Most loans from informal lenders carry a very high interest rate and do little to increase the income of the borrowers. Thus, it is necessary that banks and cooperatives increase their lending particularly in the rural areas, so that the dependence of the poor on informal sources of credit reduces.</p> <p>iii. It is important that the formal credit is distributed more equally so that the poor can benefit from the cheaper loans.</p>	3

These states were defeated.</p> <p>iv. In January 1871 the process of unification of Germany was completed.</p> <p>v. The Prussian king William I was proclaimed German Emperor</p> <p>To be assessed as a whole</p> <p><b>OR</b></p> <p>Explain the role of women in the nationalist struggle of Vietnam</p> <p>i. Women as Rebels: Writers and political thinkers began idealising women</p>	5

	<p>who rebelled against social norms. In the 1930s, a famous novel by Nhat Linh caused a scandal because it showed a woman leaving a forced marriage and marrying someone of her choice, someone who was involved in nationalist politics.</p> <ul style="list-style-type: none"> <li>ii. Heroes of Past Times: Rebel women of the past were similarly celebrated. In 1913, the nationalist Phan Boi Chau wrote a play based on the lives of the Trung sisters who had fought against Chinese domination in 39-43 CE. In this play he depicted these sisters as patriots fighting to save the Vietnamese nation from the Chinese.</li> <li>iii. One of the most venerated was Trieu Au who lived in the third century CE. She left home, went into the jungles, organised a large army and resisted Chinese rule.</li> <li>iv. Women as Warriors- In the 1960s, photographs in magazines and journals showed women as brave fighters.</li> <li>v. Women as workers -They helped in nursing the wounded, constructing underground rooms and tunnels and fighting the enemy.</li> <li>vi. Explain.</p> <p>Folklore and Indian nationalism</p> <ul style="list-style-type: none"> <li>i) Came to be visually associated with the image of Bharat Mata.</li> <li>ii) 'Vande Mataram' as a hymn to the motherland. Later it was included in the novel <i>Anandamath</i> and widely sung during the Swadeshi movement in Bengal.</li> <li>iii) Moved by the Swadeshi movement, Abanindranath Tagore painted his famous image of Bharat Mata, is portrayed as an ascetic figure; she is calm, composed, divine and spiritual.</li> <li>iv) Ideas of nationalism also developed through a movement to revive Indian folklore. Nationalists began recording folk tales sung by bards and they toured villages to gather folk songs and legends.</li> <li>v) It was essential to preserve the folk tradition in order to discover one's national identity.</li> </ul>	<p>5</p>

<p>Ans.</p>	<p>Political Party:</p> <ul style="list-style-type: none"> <li>i. A political party is a group of people who come together to contest elections and hold power in the government. They agree on some policies and programs for the society with a view to promote the collective good.</li> <li>ii. They try to persuade people as to why their policies are better than others, seek to implement these policies by winning popular support through elections. Political parties have three components – the leaders, active members and followers.</li> </ul> <p>Suggestions:</p> <ul style="list-style-type: none"> <li>i. A law should be made to regulate the internal affairs of political parties. It should be made compulsory for political parties to maintain a register of its members, to follow its own constitution etc.</li> <li>ii. It should be made mandatory for political parties to give a minimum number of tickets, about one-third, to women candidates. Similarly, there should be a quota for women in the decision making bodies of the party.</li> <li>iii. There should be state funding of elections. The government should give parties money to support their election expenses. <span style="float: right;">2+3</span></li> </ul>	
<p>26. Ans.</p>	<p>How does democracy produce an accountable, responsive and legitimate government? Discuss by giving five reasons.</p> <ul style="list-style-type: none"> <li>i. In a democracy people have the right to elect their rulers and participate in decision making that affects them all. Government thus, is accountable to the citizens and responsive to their needs and expectations.</li> <li>ii. Democracy is based on the idea of deliberation and negotiation, though it results in delays. It ensures that decision making is based on norms and procedures and allows transparency. Develops mechanisms for citizens to hold the government accountable.</li> <li>iii. Set up following practices and institutions: regular, free and fair elections; open public debate on major policies and legislations; and citizens' right to information about the government and its functioning.</li> <li>iv. It may be reasonable to expect from democracy a government that is attentive to the needs and demands of the people and is largely free of corruption. Though the record of democracies is not impressive on these two counts.</li> <li>v. Democratic government is a legitimate government. It may be slow, less efficient, not always very responsive or clean, but is people's own government. People wish to be ruled by representatives elected by them.</li> </ul>	<p>5</p>
